

**RESOLUTION FOR PARTICPATION IN  
STATE OF ILLINOIS  
FEDERAL SURPLUS PROPERTY PROGRAM  
RESOLUTION NO. 2016-05**

WHEREAS the Orland Park Public Library has limited fiscal resources available for the procurement of heavy-duty construction equipment, vehicles, commodities, and other property; and

WHEREAS, the State of Illinois' Federal Surplus Property Program offers a variety of surplus property at approximately 5-25 percent of the acquisition value, effectively reducing program costs by acquiring items that have been used to their life expectancy or property that must be replaced for safety or economic reasons; and

WHEREAS, the Orland Park Public Library located in the Village of Orland Park, agrees to the following terms and conditions to use the surplus property only in the official program which it represents; and upon receipt, agrees to place the surplus property into use within one year; and it agrees that the property shall be used for a period of one year (certain items, eighteen months); that it agrees it will not sell, loan, trade or tear down the property without written consent of the State of Illinois; and

WHEREAS, the Orland Park Public Library located in the Village of Orland Park, understands that surplus property must be used in an authorized program and that personal use or non-use of surplus property is not allowed;

THEREFORE, WE THE ELECTED TRUSTEES OF THE ORLAND PARK PUBLIC LIBRARY do hereby consent and decree that the Orland Park Public Library is authorized to participate in the State of Illinois Federal Surplus Property Program.
