

BE IT FURTHER RESOLVED that the Orland Park Public Library Board of Library Trustees, staff and community wish her the very best.

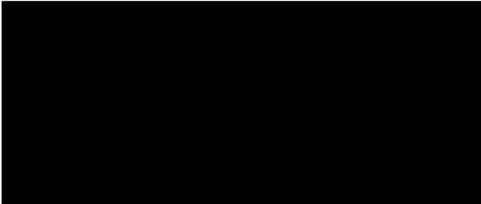
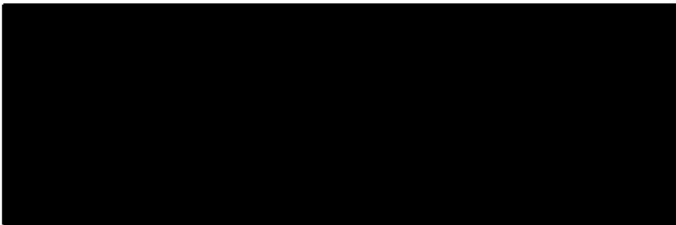
